If you initiated the dispute, the resubmission email notification will contain a unique link to a new form called the Notice of IDR Initiation - Resubmission web form and instructions on the next steps. Within 4 business days of initiation, the initiating party must electronically submit the notice of the certified IDR entity selection or failure to select to the Departments using the Federal IDR portal, available at <https://>

The Federal IDR portal is used to satisfy various functions including provision of notices, Federal IDR initiation, submission of an application to be a certified IDR entity, as well as satisfying reporting requirements.
