Does Arizona offer solar tax credits?

Who qualifies for the Arizona solar tax credit?

Homeowners file for the credit along with their personal state taxes. These are solar energy devices that qualify for the Arizona Solar Tax Credit: Those who owe less taxes than the credit can roll it over for up to five years. However, the amount of credit cannot exceed \$1,000. You must own your system to qualify.

Are solar panels a good investment in Arizona?
