Does Beauparc own bioverda power systems?

In 2017, Beauparc acquired electricity producer, Bioverda Power Systems. Bioverda - formerly Irish Power Systems - extracts methane gas from landfill sites and generates electricity for resale to electricity providers.

Where does bioverda generate power?

Bioverda generates power at a number of active and decommissioned landfill sites, at locations including Kill in Co Kildare and Dunsink in Co Dublin. Speaking to the Irish Independent, Panda founder Eamon Waters declined to comment on the price the company is paying for Bioverda.

Does bioverda produce electricity from landfill gas?

Bioverda says the acquisition makes it the main supplier of electricity generated from landfill gas in Ireland. IPS currently has installed electrical power generating capacity of 22 MWs utilising gas from landfill to generate electricity for supply to the national grid.

The company has been bought by Bioverda, the bioenergy division of NTR plc. Businessmen Michael Devaney and Patrick Keane each held 22.5 per cent stakes in IPS, while Philip Kelly and Patrick ...
