Can I use my back-up generator during a public safety power shutdown?

Contact your air district The California Air Resources Board is one of six boards, departments, and offices under the umbrella of the California Environmental Protection Agency. CARB regulations allow you to use your back-up generators during a Public Safety Power Shutoff.

Does a backup generator need maintenance?

The NFPA also requires that the oil in your generator be changed regularly. Even if it's not run regularly, impurities build up in unused oil and can impede your generator's performance when it's needed most. Thus, it too requires preventative maintenance. What are the requirements for emergency power systems & standby power systems?

1203.1.5.1 High-rise buildings and Group I-2 occupancies having occupied floors located more than 75 feet above the lowest floor level having building access. Emergency power systems and standby power systems shall be designed to provide the required power for a minimum duration of 6 hours without being refueled or recharged.

Can a backup power system be scaled up?

Therefore, while this specific installation only required 10 kW of power, it could, theoretically, be scaled up to provide higher power outputs, and using the "Desired Power Range" filter would reflect this. These are the industries and/or applications where the backup power technologies are installed.

What are the NFPA requirements for stationary fuel cell power systems?

1205.11 Ventilation and exhaust. Ventilation and exhaust for stationary fuel cell power systems shall be provided in accordance with NFPA 853. 1205.12 Fire suppression. Fire suppression for stationary fuel cell power system installations shall be provided in accordance with NFPA 853. 1205.13 Gas detection systems.

Does NFPA 110 cover a generator?

The NFPA 110 covers regulations for all Californian Commercial building owners with generators. However, each area's operational limitations and permits are set by their own individual ruling jurisdiction. Generators located in Orange County fall under the rule 1470 in the South Coast Air Quality Management District (SCAQMD).

Portable power stations, also known as battery-powered inverter generators or portable batteries, are an additional backup power option that is clean with no direct emissions from the battery. They typically have enough capacity to power only a few small appliances for a short time (see table ...

The portable power station or permanent backup generator should be on the Qualified Products List and purchased after January 1, 2024. A proof of purchase, in the form of a legible and dated receipt identifying the product, must be ...

The \$7 million grant program allows retail gas stations faster and more reliable access to backup power during an energy emergency, addressing emergency fuel supply challenges highlighted during Superstorm Sandy. Under the new guidelines, all gas stations statewide with a minimum gasoline capacity of 18,000 gallons are eligible to apply.

Under the Emergency Proclamation, the California Environmental Quality Act and related regulations are suspended for new emergency and temporary power generators that the CEC has determined meet the criteria set forth above.

CARB regulations allow you to use your back-up generators during a Public Safety Power Shutoff. CARB has released a guidance document and several advisories, regarding generator usage during PSPS events. Contact your air district before you purchase, rent or use a large (>50 brake horsepower) generator to determine if any local permitting requirements apply to you.
