



# California grant for zero solid waste recycling company

What is California's Zero Waste Plan?

California is implementing policy and legislative changes to drive the state to zero waste by reducing, reusing, repairing, and recycling resources. The Zero Waste Plan sets a path to close existing program gaps, identify what's working, and recommend what's needed for a truly circular economy.

What is the solid waste infrastructure for recycling grant program?

The Solid Waste Infrastructure for Recycling grant program funding will be allocated in two categories, the EPA says. One \$40 million segment will go in a political subdivisions category for small governments such as counties, cities and towns that want to improve materials management infrastructure.

Does EPA have a solid waste infrastructure for recycling grant program?

EPA has selected 25 communities nationwide to receive grants totaling more than \$73 million under the newly created Solid Waste Infrastructure for Recycling funding opportunity.

Does CalRecycle have a Zero Waste Plan?

CalRecycle published the Baseline Report for the Zero Waste Plan on July 1, 2024. The report evaluates the effectiveness of the department's programs and identifies programmatic and departmentwide changes needed to improve these programs. Early draft principles for a zero waste plan include: Overcome barriers to reach all mandates.

What is California doing to reduce waste & reuse?

California is building a comprehensive, circular strategy to reduce and reuse all materials. The Zero Waste Plan is due for publication in 2026. Although California has collected for recycling, still goes to landfills a year. We can do more and build new and expanded circular systems to use these materials better.

Does CalRecycle offer grants?

CalRecycle offers funding authorized by legislation to help public and private entities create circular waste systems. Open grant applications are updated often. With compostable materials accounting for 40% of the city's residential solid waste, the facility will provide a needed resource for diversion of organic waste and fits within the community's equity-centered Fair Development Plan for Zero Waste. In addition, the facility itself will be solar-powered, further reducing greenhouse gas emissions.

The Waste Permitting, Compliance, and Mitigation (WPCM) Division is responsible for CalRecycle's solid waste, waste tire, recycled content products, and local government regulatory mandates and activities. This division ensures that: Solid waste and waste tire processing and disposal site permits are processed and issued as required.
