Can a learner driver use a handheld phone?

It is also illegal to use a handheld phone or similar device when supervising a learner driver. These both apply even if you're stopped at traffic lights or queuing in traffic. are parking the vehicle remotely using an App on the phone. Can you use a hand-held phone while driving?

The device must not block your view of the road and traffic ahead. You can get six penalty points on your licence and a £200 fine if you use a hand-held phone when driving.

Should you use a hands-free device while driving?

If you have to use a hands-free device while driving, Gov.uk suggests that "The device must not block your view of the road and traffic ahead" so make sure the device is placed safely in your car for a clear view of the road.

What happens if you use your mobile phone while driving?

From 25 March 2022, using your mobile phone or any other handheld device for any purpose while driving will become a punishable offence. Using your mobile phone for calls or texting is already illegal, but even holding it while driving will now land you a penalty.
