Can I sue a solar company?

Many residential solar companies have arbitration clauses that require you to use consumer arbitration rather than go to court. If you have an arbitration clause in your contract, you won't be able to sue solar companies in state and federal courts. With arbitration, you and the solar company provide information to a neutral third-party arbitrator.

Why do people sue residential solar companies?

People sue residential solar companies over many things, like issues with their contracts, problems with installation, false advertising, or unfair business practices. The Campaign for Accountability (CFA) and the Consumers Union have raised concerns about residential solar companies with the Federal Trade Commission.

Can I sue a solar company for misrepresentation?

If so, you may be able to sue them for misrepresentation or fraud. This can include exaggerating the energy savings or making false promises about system performance. In some cases, the installation of a solar system can cause damage to your property.

How do I file a lawsuit against a solar energy company?

This can include documents such as your solar energy contract, photographs of any damage, correspondence with the solar company, and any other relevant information. While you may be able to handle a small claim on your own, it's generally advisable to hire a lawyer who specializes in solar energy litigation.

Why should you take legal action against a solar company?

The most common reasons for taking legal action against a solar company include breach of contract, negligence or defective products and services, fraud or misrepresentation, and property damage caused during installation. Breach of Contract: A breach of contract occurs when one party fails to fulfill their obligations as outlined in the agreement.

Can I sue a solar company if I have an arbitration clause?

If you have an arbitration clause in your contract, you won't be able to sue solar companies in state and federal courts. With arbitration, you and the solar company provide information to a neutral third-party arbitrator. That arbitrator reviews the information and makes a binding decision, similar to a judge.

Some common examples of solar company lawsuits have to do with misleading sales tactics, false advertising, property damage, failure to abide by the contract, financial issues with a contract, and more. Answer: At the time that solar panel companies lease or finance solar panels they generally do record a UCC-1 financing statement or similar security document to protect their ownership of the solar panels until all of the payments are made. Problems can occur when the owner of the home later wants to sell the home.

Connect panel members with solar panels. Some product offers can be legitimate and worthwhile - but sometimes they"re being mis-sold. Think carefully about the claims made about any product you"re being offered, and work out if it will benefit your system. A cold-caller on your doorstep or phone doesn"t give you time to think things through.

Yes. Based on the limited facts you provided it appears you have a claim for breach of contract against the solar contractor. Typically, when there is 30 continuous calendar days of cessation of labor and/or work at a site you have a strong argument that the contractor, here the solar contractor, abandoned your project.

Many companies include arbitration clauses in their contracts, meaning that you can"t sue them in court, but have to go before a private arbitrator who will decide your lawsuit. But arbitration has complicated rules, and most consumers don"t win unless they have an attorney.

If a solar company has misled you or failed to deliver promised services, our legal expertise can be instrumental in pursuing your claims.
