How do I sell solar power back to the National Grid?

This scheme was replaced by the Smart Export Guarantee (SEG), now the most common method of selling solar power back to the National Grid. To start benefiting from this government-supported scheme, you first need to register for the SEG tariff through an approved energy supplier.

How much money can you make connecting to the grid?

On top of these payments for energy generation, you also receive a sum of money for feeding any surplus energy into the grid. By combining these two payments with potential savings on energy bills, you stand to make up to £695 a year by connecting. How do I go about connecting to the grid? How do solar panels earn money?

A large portion of potential solar panel earnings comes from the government's generation tariff, which is part of the Feed-In Tariff (FIT) scheme. Under the generation part of this scheme, you receive a fixed rate of income for each kWh of electricity you generate.

Why should a solar PV system be connected to the grid?

For financial benefit. Connecting your solar PV system to the grid allows you to take advantage of the FIT, which gives you a fixed amount of money for each kWh of electricity you generate. On top of these payments for energy generation, you also receive a sum of money for feeding any surplus energy into the grid.

How much money can you make selling solar power?

The amount of money you can earn selling solar power back to the National Grid will depend on several interdependent factors. Some of those factors include: The energy supplier under which you register. For instance, if you have a three-bedroom house installed with 10 solar panels of 3.5kWp power, you can earn as much as £112 per year.
