

Complaining about solar panels

How many complaints are there about solar panels?

Debbie Enever, from the Financial Ombudsman Service, said: "We have got about 2,000 complaints about solar panels at the moment and more coming through every week." Loans for solar panels were taken out through Barclays Bank, which said: "We always seek to ensure customers are satisfied with our financial products."

How do I make a complaint about a solar installation?

When making a complaint it is useful to have the following information: The date of installation may be present on installation paperwork and may also be on the energy efficiency measure, such as the loft installation, the boiler, or the Solar PV inverter. Please contact the ECO team (ECO.SAR@ofgem.gov.uk) to raise a Subject Access Request.

How do I complain about my energy provider?

It's the provider's job to look into your complaint for you. Their contact details are on your Energy Performance Certificate. Contact the Green Deal Ombudsman if your complaint has not been resolved within 8 weeks, or if you are not happy with the provider's response.

When can I complain about my energy supplier?

You must complain to the ombudsman within 12 months of your supplier telling you their decision. If your supplier hasn't given you a decision you might have longer than 12 months, but it's still worth complaining as soon as you can. You can register your complaint to the energy ombudsman:

Can I complain to the Energy Ombudsman?

You can complain to the energy ombudsman if you've already complained to your energy company and either: The energy ombudsman is independent and can: In some instances, they might tell your supplier to give you financial compensation. You must complain to the ombudsman within 12 months of your supplier telling you their decision.

What if I have a complaint about the Green Deal?

Find out what you need to do if you have a complaint about the Green Deal. Contact your Green Deal provider if you have a complaint about them, your Green Deal assessor or your installer. It's the provider's job to look into your complaint for you. Their contact details are on your Energy Performance Certificate.
