Do I need planning permission for a commercial solar panel installation?

Planning permission isn't required for a surprisingly big number of commercial solar panel installations. But it's still worth checking the rules, just in case!

Can I install solar panels if I don't meet building regulations?

Your local authority can also apply for a Confiscation Order to take away any money you've earned with your system - so there's absolutely no benefit to installing solar panels that don't meet building regulations. It's crucial that your solar installation follows all building regulations.

Do solar PV installations need to be MCS certified?

Also, the Council of Mortgage Lenders has advised that, as a minimum to avoid the risk of a property being ineligible for a mortgage, both new and existing Solar PV installations must be MCS certified. All renewable energy products are examined by certification bodies against MCS manufacturing and testing standards.

Should a solar PV system be a mainly-export installation?

Solar Energy UK is actively lobbying for reform on this issue. However, by setting up solar installations under a Special Purpose Vehicle and providing a PPA to agree to export and 'sell' the electricity to the on-site 'consumer', the solar PV system should face a Business Rates valuation as a mainly-export installation.

Do I need a building regulations certificate for my solar panel system?

You should receive a building regulations certificate, known as a completion certificate, for your solar panel system. This certificate will assure you and any future owners that the work met all building regulations, which will make it much easier to sell your property at any point.
