What is New York state's energy storage goal?

This Order formally expands the State's goal to 6,000 Megawattsof energy storage to be installed by 2030,and authorized funds for NYSEDA to support 200 Megawatts of new residential-scale solar,1,500 Megawatts of new commercial and community-scale energy storage,and 3,000 Megawatts of new large-scale storage.

The Bulk Energy Storage Incentive program offers financial incentives for new energy storage projects greater than 5 MW that are connected to the grid. The energy storage system must provide services to the wholesale energy market, ancillary services, or distribution level service.

The Retail Energy Storage Incentive Program provides cost buy-downs for financial support for new grid-connected energy storage systems that are up to five megawatts (MW) of alternating current (AC) power and are either interconnected behind a customer's electric meter or directly into the distribution system.
