U.S. private-equity firm Kawa Capital Management Inc. agreed to take over Conergy AG, once Germany's biggest solar company, two weeks after the Hamburg- based company filed for bankruptcy.

(ADPnews) - Jan 20, 2010 - South Korean photovoltaic (PV) engineering company Conergy Korea said yesterday that it had peeled off from the German solar group Conergy (ETR:CGY) and will operate under the name OSolar.

The company manufactures solar components, such as photovoltaic (PV) modules, mounting systems, and off-grid and grid-connected inverters. Its products have generated more than 2.2 gigawatts of renewable energy.

BERLIN (AP) -- Germany's Conergy AG has become the latest victim of a global solar panel price war, which has already cost tens of thousands of jobs in the country in recent years. Hamburg-based Conergy on Friday filed for insolvency and said it hoped to find an investor to continue the business.

Conergy was a multinational renewable energy company headquartered in Singapore. It was founded in Hamburg, Germany, in 2000 by former CEO Hans-Martin R#252;ter, and specialized in the development, operation and maintenance of photovoltaic power plants and plant components.

ConEnergy is a Solar Energy company. Over the past decade, they have deployed over 1 gigawatt of renewable energy around the world including 400 megawatts (MW) within the Group's major projects portfolio.
