The solar system is also known as a planetary system. Since the 1990s scientists have found many planetary systems beyond our solar system. In these systems, one or more planets orbit a star--just as the eight planets in our solar system orbit the Sun. These planets are called extrasolar planets.

A fully installed solar system typically costs \$3 to \$5 per watt before incentives like the 30% tax credit are applied. Using this measurement, 5,000 Watt solar system (5 kW) would have a gross cost between \$15,00 and \$25,000. Buying a solar energy system makes you eligible for the Solar Investment Tax Credit, or ITC. In December 2020, Congress passed an extension of the ITC, which provides a 26% tax credit for systems installed in 2020-2022, and 22% for systems installed in 2023.
