Does Illinois require an LLC name?

Illinois requires your LLC name to be distinguishable from every other LLC or corporation name registered or reserved in the state. To avoid having your formation paperwork rejected, be sure to research business name availability using the Department of Business Services search engine.

What information should be included in my Illinois LLC operating agreement?

Your Illinois LLC Operating Agreement should include information about how your LLC is taxed by the IRS. The IRS treats Single-Member LLCs as Disregarded Entities for tax purposes.

How do I register an LLC in Illinois?

That's why acting as your own registered agent or asking a friend or family member to do so can be risky. The next step is to file Articles of Organization. Your Illinois Articles of Organization (Form LLC-5.5) are the formation documents that officially register your LLC.
