Can I sue a solar company?

If your solar company fails to properly install the system or causes damage during the installation process, you may be able to take legal action to seek compensation for repairs or other damages. If you find yourself in a situation where you believe suing your solar company is necessary, there are a few key steps you'll need to take:

Can I sue a solar company for misrepresentation?

If so, you may be able to sue them for misrepresentation or fraud. This can include exaggerating the energy savings or making false promises about system performance. In some cases, the installation of a solar system can cause damage to your property.

Why do people sue residential solar companies?

People sue residential solar companies over many things, like issues with their contracts, problems with installation, false advertising, or unfair business practices. The Campaign for Accountability (CFA) and the Consumers Union have raised concerns about residential solar companies with the Federal Trade Commission.

How do I file a lawsuit against a solar energy company?

This can include documents such as your solar energy contract, photographs of any damage, correspondence with the solar company, and any other relevant information. While you may be able to handle a small claim on your own, it's generally advisable to hire a lawyer who specializes in solar energy litigation.

Who is involved in a SunPower lawsuit?

Some of them have involved employees and contractors working for the companies, while others have involved customers. For instance, in 2021, a lawsuit was filed by a group of California consumers over defective micro inverters in the solar panels provided by SunPower. SunPower settled in 2022 for \$4.75 million.

Solar panel fraud occurs when a solar company makes false or misleading claims about the performance or benefits of their solar panels in order to make a sale. For example, a company might claim that their panels are more efficient or produce more energy than they actually do, or promise savings that are unrealistic or impossible.

Some common examples of solar company lawsuits have to do with misleading sales tactics, false advertising, property damage, failure to abide by the contract, financial issues with a contract, and more.
