Is solar energy project development in China still in its primary growth phase?

Solar energy project development in China is still in its primary growth phase. The year 2012 marks the first year of China's strong scale-up of solar energy capacity. Table 1.1. Growth of wind and solar power in China: capacity and generation. Includes small number of experimental demonstration projects using alternative technologies.

How much does a PV project cost in China?

According to several sources interviewed for this study, project developers in China bid in large-scale PV project tenders for as low as 1.14 USD per Watt installed since 2012. This price point is well below the Q1 2014 U.S. average of 1.88 USD per Watt.

What are the risk factors for photovoltaic project development in China?

China-specific risk factors for photovoltaic project development are identified. High cash flow risk and lack of legal recourse inhibit private sector investment. Opaque public tenders and rent-seeking lead to low field performance. High-level reform attempts fail to gain traction due to vested interests.

How many photovoltaic projects in China have faulty monitoring instruments?

Two field-testing engineers from different Chinese project certification companies estimated that 80% of photovoltaic projects in China have faulty or wrongly configured monitoring instruments, which can result in either under- or overstating production estimates in acquisition contracts.

Why did Volkswagen sell its gas turbine business to CSIC Longjiang GH?

Volkswagen-affiliate MAN Energy Solutions has decided to sell its gas turbine business to China's CSIC Longjiang GH Gas Turbine Co., as the German manufacturer shifts focus to decarbonisation solutions.

Do competitive auction schemes allow emerging markets to procure solar generation?
