Maine State Law Limits on Municipal Authority to Regulate Solar Energy Systems on Residential Property. A municipal ordinance, bylaw, or regulation adopted after September 30, 2009, that directly regulates the installation or use of solar energy devices on residential property must not run afoul of certain limits.

In December 2022, the Brookfield company Luminace bought net energy billing solar projects in Bristol, Emden and Woolwich, with 21.6 megawatts of capacity, from EDF Renewable. Between Luminance and Standard Solar, Brookfield companies have a capacity of about 113 megawatts of Maine solar.

The national average system cost is \$20,650, according to EnergySage. The average cost of solar panel installation in Maine ranges from \$14,918-\$20,182 for a 5-kilowatt (kW) system.
