

# Photovoltaic panels installed on the roof were loaned

Can you get free solar panels on a roof?

Companies offered to pay to lease your roof from you for 20-25 years and, in exchange, would install and maintain solar PV panels on it. You didn't have to pay upfront for the panels, and would also benefit from the free electricity produced by the system. But there are very few free solar panel schemes available now.

Are roof-integrated solar panels a good investment?

Roof-integrated solar panels in the UK are quite the initial investment, yet they can lead to substantial savings in the long run. Based on your property size and the solar panel size, in-roof solar panels in the UK can save you between £440 and £1,005 a year.

Technically, roof-integrated solar panels function just like traditional solar panels or solar roof tiles, using photovoltaic cells to convert sunlight into electricity. However, instead of sitting on top of the roof on visible brackets that can affect your home's aesthetic appeal, they become a part of the roof structure itself.

Can I refinance a house with solar panels?

You may be looking to refinance a house with solar panels or get a mortgage for a property with solar panels. Some mortgage lenders won't lend to applicants for houses with leased solar panels. If the solar panels are outright purchased, and there is no lease or loan agreement, then you can apply for a mortgage as usual.
