In 2020, the plaintiffs bought a solar system for their home from a solar panel company called Power Home Solar (d/b/a Pink Energy) ("Pink Energy"). Id. at ¶ 11. They paid approximately \$47,000. Id. at ¶ 22. In October 2022, Pink Energy filed for Chapter 7 bankruptcy. Id. at ¶ 3. GoodLeap was a California company that provided financing ...

It also seeks an order requiring Pink Energy to "reimburse all consumers found to have been damaged" by Pink's "unlawful actions."

On August 1st, 2022, Power Home Solar (DBA Pink Energy) filed a lawsuit against Generac Power Systems in the U.S. District Court in Virginia. Throughout the 37 pages of its complaint, Power Home Solar's lawyers lay out arguments claiming Generac has caused "ongoing financial damage and extraordinary harm to its business reputation."

Pink Energy filed a federal lawsuit against Generac that same month as thousands of customers across the country filed complaints against Pink Energy. The company shut down in September 2022 and ...
