On April 15, 2023, NEM 2.0 closed to new customers and a new Solar Billing Plan went into effect. NEM accounts will continue to bill under the current NEM program until the 20-year period expires, or until the account loses eligibility to remain on the NEM program, whichever is earlier.

For customers considering solar and other renewable generation 1 at their homes, the Solar Billing Plan is designed to help modernize solar rates to promote grid reliability, incentivize solar and battery storage, and help control electricity costs for all Californians. Each month, billing will include charges for energy used from the electric grid, as well as energy credits exported to ...

Update: NEM 3.0 took effect on April 15, 2023 and the window to grandfather new solar systems into NEM 2.0 is closed. If you submitted an interconnection agreement on or before April 14, 2023, your system can still be grandfathered into NEM 2.0 even if your utility reviews and approves your application after the submission deadline.
