If you're a New York State resident interested in filing for a renewable energy tax credit, you will need to complete the appropriate forms to submit along with your normal yearly tax filing. The most commonly used forms and instructions are listed here. We also encourage you to consult an accountant or tax advisor if you have any questions.

The following Residential Clean Energy Tax Credit amounts apply for the prescribed periods: 30% for property placed in service after December 31, 2016, and before January 1, 2020 26% for property placed in service after December 31, 2019, and before January 1, 2022

Section 168(e) provides favorable depreciation treatment for facilities or property qualifying for this tax credit.
