Are solar inverters taxed?

Solar inverters,which convert the DC electricity generated by solar panels into AC electricity used by most appliances,are taxed at a GST rate of 12%. Similarly,solar lanterns,which are portable and often used in off-grid areas,also fall under the 12% GST bracket.

Is a solar panel/module classifiable under Customs Tariff?

(1) If the solar panel/module is equipped with elements and these elements supply the power to an external load i.e,motor,an electrolyser etc.,then the solar panel/module is classifiable under Heading 8501of the Customs Tariff.
