Tax relief eligibility for battery storage Projects The expanded tax relief encompasses three main categories of battery storage projects, each contributing towards the enhancement of the UK's energy grid's resilience and sustainability:

Are battery energy storage systems exempt from VAT?

Effective 1 February 2024, the UK government has exempted retrofitted battery energy storage systems (BESS) from the 20% VAT. This recent and welcomed development means homeowners looking to upgrade their homes with energy storage now enjoy the same tax benefits as those incorporating energy-saving materials like heat pumps and roof-mounted solar.

Are solar and energy storage installations subject to VAT?

All solar and energy storage installations, including maintenance to existing sites, should be subject to 0% VAT. This should include residential energy storage when installed as a standalone measure.

What is the VAT rate on solar?

VAT on a range of domestic energy efficiency and renewable energy installations, including solar, is now 0% in Great Britain. This is a reduction from the previous rate of between 5% and 20%. Eligible installations are those included on the Government's list of Energy Saving Measures (ESMs).

Do solar panels qualify for a reduced VAT rate?

In the UK, the value-added tax (VAT) rate on most goods and services is 20 per cent. As part of the government's efforts to encourage energy efficiency and the adoption of sustainable energy systems, certain energy-saving materials and equipment, which include the best solar panels, qualify for a reduced VAT rate.
