Does USPS ship lithium-ion batteries?

If you're sending a used item containing lithium-ion batteries, you must use USPS Ground Advantage service, since the item must be handled through surface transportation only. Like all hazardous materials, shipping lithium-ion batteries all comes down to packaging properly.

Are lithium ion batteries mailable?

Except as provided above, individual lithium metal (or lithium alloy) and lithium-ion (or lithium polymer) batteries (without equipment) are mailable in limited quantities via surface transportation only, provided the batteries are in the originally sealed packaging, and packaged and marked as described in 349.221 and 349.222, as applicable.

Can a lithium battery be attached to a mailpiece?

Except for mailpieces containing button cell batteries properly installed in the equipment they are intended to operate, mailpieces containing mailable lithium metal or lithium-ion batteries must be rigid, sealed, and of adequate size, so the lithium battery mark can be affixed to the address side without the mark being folded.

Can I ship lithium batteries overseas?

For shipping lithium batteries with USPS overseas, you can ship a maximum of 4 cells or 2 batteries that are installed in the new or certified refurbished equipment or device it operates, without any lithium battery markings. However, individual batteries are prohibited from USPS international shipping.

Are rechargeable lithium-ion batteries safe?

While rechargeable lithium-ion batteries are the most popular choice for powering devices, they come with potential shipping hazards. These batteries can produce a high level of heat if short-circuited, and the chemical contents can catch fire.

Additionally, pre-owned, damaged or defective electronic devices -- such as cellphones, laptops, tablets -- that either contain or are packed with lithium batteries must be mailed by surface transportation using Parcel Select

The U.S. Postal Service has announced new final rules, effective immediately, that significantly impact the shipping of lithium batteries and other hazardous materials by mail.. USPS cites "a consistent and alarming rise in incidents involving mailed packages of both lithium batteries and other hazmat, including ... unlabeled or improperly labeled air-ineligible hazmat ...

You may only use the Ground Advantage shipping service, as electronics with used or damaged lithium-ion batteries cannot be transported via air. If you're shipping multiple items, separate the lithium-ion batteries or electronics containing lithium-ion batteries into a different package.

Lithium batteries are dangerous goods, and all of the regulatory requirements must be complied with, as set out in the Lithium Battery Shipping Regulations. In the United States, failure to comply with these regulations can result in a civil penalty of up to \$27,000 per offence (LBSR 1.3).

Ground transportation requirement: USPS only permits lithium battery shipments via ground transportation due to safety concerns related to overheating and fire hazards during air transport. Packaging and labeling guidelines: When shipping lithium batteries via USPS, proper packaging and labeling are essential.

When using an air transportation service like Priority Mail, you'll need the UN3481 Lithium Battery Handling Label. Sometimes, you may need to ship with a ground-based service, like when the lithium ion batteries are separate from the equipment they power. In this case, you'll need to affix this UN3480 label.

A mailpiece containing mailable hazardous materials utilizing Parcel Select Lightweight or USPS Ground Advantage must not, under any circumstance, be transported on air transportation, except for items in 327.2 g. ... UN3090 lithium metal batteries (including lithium alloy batteries) and UN3480 lithium-ion batteries (including lithium polymer ...

YES, you can ship Lithium Ion and Lithium Metal via air mail, any mail class. The only thing you cannot ship via air is Lithium Metal batteries without any other equipment. Lithium Metal are nonrechargeable, usually watch batteries or film camera batteries. Most lithium batteries are rechargeable lithium ion.

Each lithium metal cell and battery must contain no more than 0.3 gram of lithium content. Each lithium-ion
