



Verdict on photovoltaic bracket fraud case

Who were the victims of a £17m solar scheme?

Today a jury at Liverpool Crown Court found six men guilty of running a £17m fraudulent scheme to install solar panels which defrauded 1,500 victims including elderly, retired and vulnerable people.

How did 'bullying' and 'cold-calling' get people to buy solar panels?

They then used cold-calling and 'bullying' selling tactics to get people to buy solar panels and other products that were often unsafe, unsuitable and in some cases never installed. MacDonald and two others were sentenced at Nottingham Crown Court on Friday.

David Diaz, Ludovic Black, Stephen Wilson, Robert Ross, Niall Hastie and Kenneth Reid were found guilty of conspiracy to defraud by false representation. Gary McVey was acquitted. What was the fraud?

Did SFO prosecute a person for a SCPO breach?

The group sold solar panels through their Manchester-based company, Solar Energy Savings Ltd., making false promises that their victims' money would be invested and returned to them in full in five years' time.
